The website even has a Retirement Estimator, to view, go to www.socialsecurity.gov/estimator. No matter what stage you are in your working career, this function of the website will give you an instant, personal estimate of your future retirement benefits. This is an invaluable tool for seeing where you are at with benefits and what you need to do to obtain your retirement goals.
